### COURSE DESCRIPTION:

This course aims to provide an understanding of basic econometric techniques with an emphasis on applications in empirical research. The first half of the course covers a comprehensive review of the classical regression model and the underlying assumptions. The second half of the course presents models that are frequently used in empirical research such as qualitative response regression models, instrumental variables and time-series analysis.

### COURSE OBJECTIVES:

"Econometrics" is a field in economics that focuses on measurement issues related to economic models and data. It combines economic theory, statistics, and computer science. What distinguishes econometrics from statistics is the attention to the failure of many standard assumptions, which arises from the nature of economic relationships and the lack of controlled experimentation.

This course aims to introduce the students to the important ideas associated with elementary econometrics. Topics and issues covered in this course will constitute as building blocks for advanced econometrics courses in the graduate programs as well. Throughout the first part of the course, we will spend some time reviewing the fundamentals of a classical normal linear regression model. We will consider how to choose estimation rules consistent with the model under study, sampling properties of estimators, making inferences using the linear regression model, the computer implementation of the techniques to obtain results from empirical applications, and the validity of assumptions we make in deriving the Ordinary Least Squares estimators (OLS). The second half of the course covers fundamental issues for conducting regression analysis in practice such as qualitative response regression models, instrumental variables, and an introduction to time series models.
