Course Description

This course is an introduction to the study of public sector economies. We will focus on the topics related to public finance in Canada. Specifically we will discuss the redistribution of income through the public provision of goods and services, the theory of public goods, the problem of externalities in a market economy, public sector pricing and investment rules, the incentive effects of taxation, tax incidence, and the measurement of the deadweight loss of taxation.
